As per the approval of higher authority of Health & Family Welfare Department, Govt. of Tripura, it is hereby notified, regarding the doubtful achievement of qualifications (D. Pharm, B. Pharm etc.) submitted by applicants for New Pharmacist registration from Tripura State Pharmacy Council (TSPC), Gurkhabasti, Agartala. Now in this regard, Government of Tripura introduces the following provisions to bring clarity on the issue of Mark-sheets, Certificates of the candidate, applying for New Pharmacist Registration. The Provisions are as follows

- 1. TSPC can ask the concern University, State Board of Pharmacy Education & College to supply the list of Admitted Students & Pass-out Students for an Academic Year.
- 2. Verification may be carried out by involving respective University and Board, from where students had obtained their Marksheet and Certificate.
- 3. The photocopies of attendance register of the students recorded during training in respective hospital or industry may be obtained.
- 4. Till the verification process is ended, issuing of Pharmacist Registration may be stopped for time being.
- 5. Necessary steps may be taken so that all the Degree & Diploma may be asked to come across Exit Examination.
- 6. Online registration may also not be entertained at this moment.
 This will come into force with immediate effect.
